### Eligible Participants

- O All immigrants who legally reside in Korea, including ethnic Koreans with foreign nationalities, international students, foreign workers, marriage migrants, refugees, high-skilled foreign professionals, etc.
- O Naturalized Koreans who have acquired Korean national within the past 3 years

# ☐ Benefits of completing KIIP: naturalization, permanent residence, change of sojourn status


- ① Exemption from the written and oral tests when applying for the acquisition of nationality, reduction in the waiting period for the assessment to acquire nationality
- ② Granting additional points when applying for an F-2 visa given to points-based high-skilled foreign professionals
- ③ Exemption from submitting a TOPIK certificate
  - When a long-term foreign resident applies for an F-2 visa
  - When a long-term foreign resident applies for an F-5 visa
  - When a marriage migrant (F-6 visa holder) applies for an F-5-2 visa
  - When an underage foreign-born child of a Korean national (F-2-2 visa holder) applies for a F-5-3 visa
  - When an ethnic Korean with a foreign nationality eligible

- for general naturalization applies for an F-5 visa
- When a non-professional visa holder (E-9), a maritime crew visa holder (E-10), or a work & visit visa holder (H-2) applies for a foreign national of special ability visa (E-7)

#### ☐ Introduction of KIIP-linkage program

- O Governmental organizations, universities, corporations, or groups operating Korean language and culture education courses equivalent to the Level 4 of the KIIP (Korean Language & Cultrue: Intermediate 2) can register their courses as KIIP-linkage program at the immigration office in their residential area.
- O Immigrants who have completed the KIIP-linkage program (equivalent to the KIIP Level 4) provided by organizations mentioned above can apply for the mid-term test (KIIP-KLCT), and they are granted the same benefits as KIIP participants when passing the test.
